ABOUT THE WORKSHOP

A large number of students who we spoke to expressed their concern about how evidence law as a discipline when taught in law schools covers only theoretical aspects, and completely misses the practical. Students told us that there exists a vast gap between what is taught in law schools generally, and what they witness in their internships or traineeships. Taking note of this concern, we at LexGaze resolved to conduct a workshop that deals exclusively with the PRACTICE OF EVIDENCE LAW.

What kinds of evidence are admissible in a court of law and what aren't? What even is hearsay? What does "Res gestae" mean really? Hold on, what is "fact"? Never thought that something as simple as "fact" could mean so much more? What is this web???

Well, these are questions you will find answers to in what will be an experience like none other, with over four hours of teaching focussed on evidence law in action, and not in books! Naturally, considering the vast canvas to be covered, four hours is not enough, and accordingly, the workshop will be divided in two parts, with the second part set to be launched in the next month or later!!

What is Evidence and why is it SO important?	A brief discussion on what evidence means, why it is absolutely important for one to be thorough with the provisions of the Indian Evidence Act, whether they are practicing on Civil, Criminal or Commercial sides
The mammoth called "FACTS"	Discussion on what does FACT really mean, not just in theory but in practicality- how to identify relevant facts and facts you can use in court of law
Proved, Disproved, Not Proved, May, Shall and Conclusive Proof	Discussion on all of the above terms with practical examples on what amounts to proving, disproving etc
Relevance and Admissibility	Probably one of the most important discussions on Day1, we will talk about which facts are relevant and which aren't, which you can use in court and which you cannot
Circumstantial Evidence	Discussion on what is circumstantial evidence, how you can win cases JUST by circumstantial evidence too, practical examples
Admission and Confession	Detailed Discussion on Admission and Confession, what the terms mean, how are they different, which admissions and confessions are admissible, and links with CrPC
Dying Declaration	Through important cases such as Nirbhaya and Unnao rape cases, learn what dying declaration is and all about its admissibility
Expert Opinions	Learn about the weight of Expert opinions, how they can make or break your case





Conduct and Character of Parties

Learn the relevance of the conduct and character of parties in evidence law, how it affects the cases in practice
