The application is open for any student of 3-year LL.B. or 5-year LL.B. or pursuing LLM, Ph.D., M.Phil. or any other master's or terminal law degree in India or abroad.

WHAT ARE WE LOOKING FOR?

The applicants will be judged on the following qualifications:

1. Expertise and experience in the specialist field applying for, related to the Journal.
2. Publication record of a number of articles and /or books (usually in / related to the specialist field).
3. Past experience as an Editor/ Reviewer in any Law Journal/ Blog-site.
4. Excellent written communication skills.
5. Confident verbal communicator (by phone, in person, in groups).
6. Good attention to detail.
7. Strong organizational and time-management skills.
8. Awareness of current challenges and opportunities in legal publishing.

5. Helping monitor journal performance.

SELECTION PROCEDURE

1. The management will short list member applications based on their Résumé, Published Articles, Past Experience and SOP.

4. All applicants interviewed will be notified about their selection/rejection.
